I. APPLICABILITY AND DEVIATIONS

These General Sales Conditions are valid for all orders sent to us, excluding any and all terms and conditions of the client. The client is considered to have accepted them by the fact of his order. Deviations from these sales conditions, even if based on documents from the client or from our sales representatives, are only applicable to us if confirmed by us in writing. Even then, for all the remaining points these sales conditions remain valid.

2. QUOTATIONS AND ORDER CONFIRM ATIONS

Unless stated otherwise in writing, our quotations are valid for information purposes only. Our company is only bound after our confirmation of the client's order. Any existing or claimed inaccuracies in our order confirmation are to be made known in writing, on penalty of lapsing, within 7 calendar days of this confirmation.

3. TERMS OF DELIVERY

The delivery terms stated by us are for information only and never binding. Failure to comply with the stated terms of delivery may never give rise to a claim for compensation or breach of contract. Circumstances beyond our control or decisions by higher authorities, give us the right to cancel or delay any order, in whole or in part, without either notice or compensation. War, mobilization, blockade, partial or complete strikes, lock out s, riot s, epidemics, bad weather conditions, machine faults, fire, explosions, which hinder the delivery of our supplies of raw materials, fuel and production stock, as well as any similar circumstances which may be suffered by our company or its subcontractors and suppliers, are considered circumstance s beyond our control.

4. TRANSPORT, RISK, COLLECTION AND PART DELIVERIES

Unless agreed otherwise in writing, all our deliveries are made EX WORKS, or from the factory or warehouse of our choice, and the transport is always chargeable to the client. Even if, by agreement of a different place of delivery, the goods are sold carriage paid, they are still transported at the purchaser's risk. We are entitled to make partial deliveries.

5. PAYMENT- RESERVE OF OWNERSHIP

All our invoices are payable immediately at the address on the invoice, unless otherwise agreed between the parties in binding documents or unless a due date is stated on the invoice. An agreed interest of I % per month, is due without notification and by legal right on failure to pay immediately or by the due date, on the amount of the invoice, to be calculated from the date of the invoice or from the due date. Every month started will be calculated as a complete month. Moreover, the amount of the invoice will be increased by 15% with a minimum of 125,00 Euro, without notification and by legal right, on a fixed and irreversible basis, as compensation for the collection costs of the debt claim (such as staff and administration costs, management and followup of the file, influences on financial management, etc.). This payment is owed in addition to the interest for delayed payment, the claimable costs of the procedure and any compensation for material damages or loss of profits. Checks, drafts and bills of exchange are only valid as payment after their redemption. Any costs of these are payable by the client. Drawing and/or acceptance of bills of exchange, draft and other commercial paper contains no renewal of debt and forms no deviation from the general conditions. The costs of accepting bills of exchange,

drafts and other commercial paper are payable by the client. In the event of non-payment of an invoice by the client, the vendor has the right to cancel the execution of any remaining contractual commitments. All goods which are not completely paid remain our property in their totality, any advances paid then serve to pay the costs and loss of profit. In the event of failure to pay, the vendor is always entitled to take back the goods from the client. The vendor shall in that case notify the client in advance, by registered letter, that he is in default and allocate a term of payment of 7 calendar days.

6. COMPLAINTS

Complaints related to the supply of goods and services or the carrying out of work must be made on delivery and confirmed by a registered letter stating the case, within 7 calendar days of the date of delivery or execution; these complaints do not suspend the obligation to pay. Remarks and restrictions in connection with the invoice and/or the general conditions stated thereon should be sent to us by a registered letter stating the case, within 7 days of the invoice date; in connection with the regulation of disputes this term amounts to 30 days.

7. WARRANTY - LIABILITY

The client shall hold us fully harmless for any and all after-sales claims that any person or entity would file against us with respect to the delivered products. If a product is faulty and causes any damages, any liability for such damages shall be limited to direct damages and the price of the product. No other damage can be charged to us, either as far as damage to the client is concerned or damage suffered by a third party through this contract, and this even if physical injury is involved. The client will have to indemnify us against any claim from whomsoever it comes. This liability is also in force if, for whatever reason, our technicians or other personnel have offered help or advice, directly or indirectly, on the choice of the product to use or the treatment and use of it. Our instructions for use and any guarantees contained in our promotional literature, or promotional literature originating elsewhere, do not diminish the above stipulations and do not give rise to our liability.

8. LANGUAGES

The fact that the client may not have received our General Sales Conditions in his native language does not release him from their application.
